1. CONTENTS OF THE SERVICE

Hansard Finance Bill Service contains edited highlights of the Finance Bill Hansard debates which will be available on the site throughout the Bill's progress through Parliament. Sometimes the debates can be particularly valuable when it comes to interpreting the meaning behind a particularly tortuous piece of legislation and this is of primary importance to practitioners. Whole tax cases might turn on the content of the debates since it is key to understanding *intent* behind the legislation, and therefore may shed light on a contested tax point.

It is a unique service complementing and augmenting our existing Finance Bill Service on Tax Direct.

2. OPENING THE SERVICE

There are three ways to access Hansard Finance Bill Service:

1. Through Tax Direct News
2. Through Tax Direct Libraries; and
3. Directly through the link on the Tax Services page.

You will not be able to access the site unless you are subscribed to the Hansard service.

To access Hansard Finance Bill Service through any of these methods, first select 'butterworths services' from the Butterworths Lexis Direct home page (single click) and then left click 'Tax Services', pictured below.



The next screen you see will be the Tax Services page. From this page select either Tax Direct News, Tax Direct Libraries or Hansard Finance Bill Service, depending on your subscription.



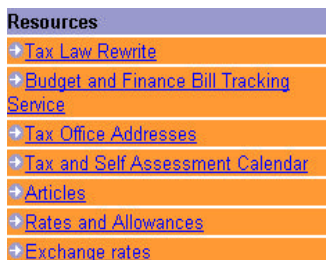
